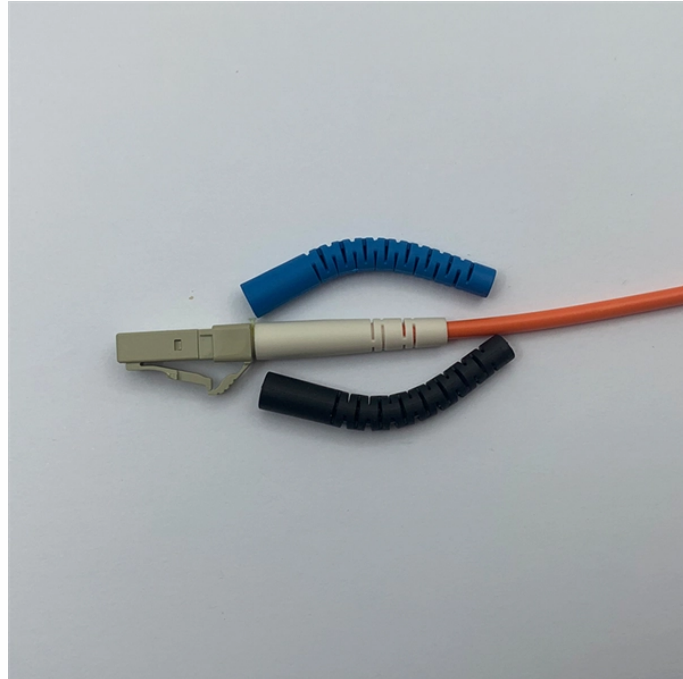


Are imported optical modules subject to tariffs



Overview

At present, the import of optical modules into the United States requires a 10% basic tariff, but according to Executive Order No. import Harmonized Tariff Schedule (HTS) code for optical modules is 8517. 00" shows the result "General Free1/", which indicates that attention should be paid to 9903. The HTS is based on the international Harmonized System, which is the global system of nomenclature applied to most world trade in.
